

Pennsylvania Department of Health, Bureau of Emergency Medical Services Enforcement Actions and Disciplinary Actions Against Emergency Medical Service Agencies Including Conditional Temporary Licenses. (Updated: November 17, 2011)

EMS Disciplinary Actions

The following is a listing of disciplinary and corrective measures imposed by the Department of Health under the Emergency Medical Services Systems Act (Act), 35 Pa.C.S. §§ 8101-8157, the prior Emergency Medical Services Act, 35 P.S. §§ 6921-6938, and other applicable laws. Additions will be posted periodically. Please note the names of persons listed may be the same or similar to the names of persons who have not had discipline or corrective measures imposed upon them.

Each entry includes the name of the individual or organization (person) against whom the discipline or corrective measure was imposed; the person's certification, license, or other identification number issued under the Act (if any); the statutory basis for such action; a brief description of the discipline or corrective measure imposed and the type of certification, license or other authorization impacted; and the effective date of the order.

Every effort has been made to ensure that the following information is correct, however, the information is summarized and is not an official record. Also, the information is not designed to describe a person's current status under the Act.

No entry is made for a person who applied for a license, certification or other authorization under the Act, and whose application was denied, unless that denial was administratively appealed and affirmed on appeal or the appeal resulted in the application being granted subject to conditions. Also, some entries identify a person who applied for a certification and who was given the opportunity to secure a certification subject to certain conditions, but who has not secured a certification because the person has not met the conditions to qualify for the certification.

Also, pursuant to the terms of the discipline, some of the suspensions identified may not have been actively served or served for less than the full term of the suspension. This is because terms of probation may have been offered as a condition for staying or lifting the suspension. When probation is offered terms for beginning the probationary period may or may not have been satisfied and, if probation was commenced, it may or may not have been successfully completed. That type of information does not appear for an entry, but can be obtained by contacting the Bureau of EMS.

Official confirmation of the current status of a person regulated under the EMS Act may be obtained by contacting the PA Department of Health, Bureau of EMS, Room 606 Health and Welfare Building, 625 Forster Street, Harrisburg, PA 17120-0701.

The Bureau, on an annual basis during the month of July, will review the listing of disciplinary and corrective measures and purge actions from the list as follows:

- Criminal Convictions: if a person has been convicted of multiple crimes, the most serious conviction will control as to the applicable number of years that the person will be listed on this notice. Pursuant to the Act, a conviction includes a judgment of guilt, a plea of guilty, or a plea of nolo contendere.
 - Felony convictions that have been listed for a period of 5 years and the provider has not committed a violation of the Act and has not been convicted of felony, a crime related to the practice of the EMS provider, or a crime involving moral turpitude, during that 5 year period.
 - Misdemeanor convictions that have been listed for a period of 2 years and the provider has not committed a violation of the Act and has not been convicted of felony, a crime related to the practice of the EMS provider, or a crime involving moral turpitude, during that 2 year period.
- Other disciplinary sanctions that have been listed for a period of 5 years after the completion of the disciplinary sanctions and where all requirements of the action have been satisfied and the individual has not committed a violation of the Act during that 5 year period or has been convicted of felony, a crime related to the practice of the EMS provider, or a crime involving moral turpitude, during that 5 year period.

Individuals who have had their certification revoked and individuals who are on the Megan's Law Web Site for Pennsylvania or any other state shall remain permanently on the listing of enforcement actions.

Having an individual's name removed from the listing of disciplinary actions does not constitute an expungement of the disciplinary record. This record will be maintained by the Bureau of EMS and will be provided pursuant to any official written inquiry. The Bureau maintains final decision on which disciplinary actions are removed from this list.

These procedures are subject to change without notice from the Bureau. Any changes that are made will be publicized on the Department of Health's website and will be made available to those individuals who contact the Bureau directly.
